- 9) Legislative –Stacey Falls
  - i. We spent our meeting last week talking about legislation that would support a woman's right to choose. We wanted to work on supporting legislation that affirms choice and privacy and access to abortion services.
  - ii. We were inspired by the Santa Cruz City Council who passed a resolution in support of 10 different bills, and we decided to do the same. For some of us, the fact the SC City Council agreed unanimously on this was enough. I think we are ready, as a committee to recommend that the DCC do the same.
  - iii. Of course, we want to make sure we do our due diligence and understand the bills we are supporting, and we think some of you will too. So we are working on a document that outlines the 10 different bills supported by the City Council, with a description of each of them.

- 2) Democratic Club of North Santa Cruz County– Linda Kerner
  - i. North County Dems are participating in a letter writing campaign with Swing Left focusing on flippable midterm races in Arizona and Nevada.

And in District 3 Maria Orozco is facing the possibility of an opponent. All 3 will be on our agenda for endorsements at our next meeting.
  - iv. We will also discuss endorsements for some measures and candidates on the Santa Cruz ballot including the Empty Homes Tax, and the parking garage/library.
  - v. Fundraiser for Felipe Hernandez on Thursday Aug 25, 6pm at Jalisco's. We would appreciate DCC support with this race, as you know Felipe's opponent lied to voters misleading them into thinking you and the Democratic Party endorsed him. The campaign clearly has its work cut out.
