- i. The first comes from Adam. It is support for Cabrillo College's application to the state for housing funds. The resolution is attached as a pdf. Here is a quick summary:
 - The state set aside \$750 million for housing for colleges: community colleges, CSUs and UCs. 50% is supposed to go to community colleges. Cabrillo applied for 6.8 million for a 300 bed set of units, but they didn't get the full funding. They got \$241k. They used that money for an EIR in preparation for a stronger grant. They are now in partnership with UCSC who will contribute \$70 million in order to build a 624 bed unit, but the construction will likely be over \$120 million. Cabrillo is asking the state to contribute the shortfall. Adam wants us to sign on to a general letter of support to our state reps and the folks who are making the allocation decisions.
- ii. Next, the legislative committee is supporting a bill that Andrew introduced to us, SB252, fossil fuel divestment from STRS and PERS (L. Gonzales. We are recommending that the DCC support this bill with Andrew writing the letter of support. Here is a fact sheet we were looking at.
